**LOCATION** The café is located in the heart of Petts Wood bustling Station Square just minute's walk from the mainline railway station which provides a fastest journey time of 22 minutes to London Bridge, 34 minutes to London Charing Cross and 36 minutes to London Victoria. Petts Wood lies south of Chislehurst, South East of Bromley and north of Orpington with junction 3 of the M25 approximately 6km away. The locale is a vibrant mix of both independent and corporate operators including Barclays Bank, Costa Coffee, Iceland, Papa Johns, Sainsburys and William Hill.

**DESCRIPTION** The demise is fully fitted to a high standard and is laid out solely on the ground floor providing around 36-40 covers. A 3-group coffee machine and marble display counter are located to the front of the property whilst towards the rear are the WC, stores and prep / washing up area. There is rear access for deliveries if required that includes space to park and for bins. In all the property extends to approximately 929 ft² / 86.3 m² GIA.
